

# Privacy Policy

Effective Date: January 15, 2018

This privacy notice discloses the privacy practices for Predictive Futures Management LLC and our website: <http://www.predictivefutures.com>. This privacy notice applies solely to information collected by this website, except where stated otherwise. It will notify you of the following:

- What information we collect;
- With whom it is shared;
- How it can be corrected;
- How it is secured;
- How policy changes will be communicated; and
- How to address concerns over misuse of personal data.

## Information Collection, Use, and Sharing

We are the sole owners of the information collected on this site. We only collect or have access to information that you voluntarily give us via email or other direct contact from you. **We will not sell or rent this information to anyone.**

We will use your information to respond to you, regarding the reason you contacted us. We will not share your information with any third party outside of our organization, other than as necessary to fulfill your request, e.g., notify our preferred broker of your interest and/or notify the preferred broker you have chosen to do business with. You may have already contacted this preferred broker, and shared information with them, before even contacting us.

Unless you ask us not to, we may contact you via email in the future to tell you about our services, your subscription status, or changes to this privacy policy.

## Your Access to and Control Over Information

You may opt out of any future contacts from us at any time. You can do the following at any time by contacting us via the email address or phone number provided on our website:

- See what data we have about you, if any.
- Change/correct any data we have about you.
- Have us delete any data we have about you.
- Express any concern you have about our use of your data

## Subscriptions

When leasing use of our software from us via subscription, you must provide contact information (like name and email address). This information is used for communication purposes to notify the preferred broker of your interest in using our services. If we have trouble processing your request, we'll use this information to contact you.

## **Payment**

When paying for your subscription, if you pay via check, the information on your check is provided to us, but is only used to process your payment; if you pay via credit card, you must provide contact information (like name, address, and email address) and financial information (like credit card number, expiration date, etc.). Credit card information is usually provided directly by you to a 3<sup>rd</sup> party for processing. This information is used for billing purposes and to keep your subscription current. If we have questions about your subscription and due dates, etc., we'll use this information to contact you.

## **Sharing**

We partner with another party to provide specific services (like credit card processing and brokerage services). When the user signs up for these services, we will share names, or other contact information that is necessary for the third party to provide these services. These parties are not allowed to use personally identifiable information except for the purpose of providing these services.

## **Security**

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline. Wherever sensitive information is collected (such as credit card data), that information is encrypted and transmitted to the processor in a secure way. You can verify this by looking for a closed lock icon at the bottom of your web browser, or looking for "https" at the beginning of the address of the web page.

While encryption is used to protect sensitive information transmitted online, we also protect your information offline. Only employees who need the information to perform a specific job (e.g. billing or customer service) are granted access to personally identifiable information. The computers/servers on which we store personally identifiable information are kept in a secure environment.

## **Cookies**

We do not use "cookies" on this site. A cookie is a piece of data stored on a visitor's hard drive to help identify repeat visitors to a certain web site. If we are using Google Analytics or other similar service(s), they may collect general informational cookies, however we have no control over these cookies.

Some of our business partners may use cookies on our site (e.g., credit card processors). However, we have no access to or control over these cookies.
